Bill At The Till 2022 Terms & Conditions

Acceptance of these Terms & Conditions is a condition of entry into this competition.

How to enter & prize details –

- The promotion dates are from Tuesday 1st March to Thursday 31 March 2022 at Mount Sheridan Plaza.
- A Centre Management staff member will walk through the mall and approach shoppers at random as they are about to pay for their items, explain the promotion and upon agreement, proceed to pay for the shopper's purchase.
- Winners will be selected weekdays during business hours.
- In the event that the nominated retailer or shopper is unable to participate in the promotion for whatever reason, another retailer and winner will be selected.
- The maximum single prize value is \$250 with the total prize pool for the promotion period being \$5000.

**ELIGIBILITY, TERMS & CONDITIONS**

1. Entry is open to residents of the Cairns Region from Atherton to Cardwell and all postcodes in-between aged 18 or over.
2. There is no minimum purchase required, however the maximum single purchase value is \$250. If the participant has more than the nominated \$250.00 maximum they may pay the difference after the \$250 maximum limit has been reached. Any goods over the value of \$250.00 will be returned to the store if the nominated entrant would not like to purchase them.
3. It is a condition of accepting the Prize that the Winner may be required to sign a legal release prize letter.
4. Employees and retailers of Mount Sheridan Plaza and immediate families are ineligible to enter. "Immediate family member" means any parent, spouse, sibling, child, defacto and/or any other family member residing at the same address as that person.

6. Persons selected at random that meets all eligibility requirements are deemed a winner.
